



NHS Performer List Regulations 2004 vs 2013

Regulation 4 - Applications for Inclusion

- 4 (2) (g) where available, provision of copy of most recent appraisal
- 4 (2) (h) insurance/indemnity cover?
- 4 (5) (i) notification of involvement in inquest critical of conduct

And NHS England policy requiring OH declaration

Wessex Area applications on average 10 per month



NHS Performer List Regulations 2004 vs 2013

Regulation 12: Suspension

12 (6)

immediate suspension

12 (12)

- subject to 12 (19)
- period of suspension = 6 months except
 - if 12 (1) (a) suspension, when suspension remains effective after decision to remove made and that decision takes effect

12 (21)

 power to lift suspension if it will not compromise the protection of the public or members of the public or in the public interest at any time, immediately



NHS Performer List Regulations - Conditions

Criteria

 prevention of any prejudice to the efficiency of services OR for the purpose of preventing fraud

When - on initial inclusion or continued inclusion

How - first by notice proposing conditions:

- Allegations and Action proposed?
- Grounds?
- Opportunity to make written representations within 28 days?
- Opportunity to put case at an oral hearing if so requested with 28 days?



Performance Screening Group

Not responsible for making decisions under 2013 Regulations

Advise on handling of individual cases

Meet monthly

Core Membership

- Chair is Senior Manager responsible for quality and performance
- GP appointed by the Responsible Officer
- Appropriate clinicians
- Direct report to Head of Primary Care
- Local Representative Committee (LRC)



Performers List Decision Panel

Purpose

- management of performance, decide on actions required per case in line with 2013 Regulations
- Meet monthly

Core Membership (4 required to be quorate)

- Independent lay chair
- Medical Director (or nominated deputy)
- Nurse Director of AT (or nominated deputy)
- LRC nominee discipline specific
- Senior manager for quality and performance (core members cannot be members of PSG or be involved in screening except for senior manager)

Immediate suspension: decision may be by 2 core members outside PLDP meeting

Regulation 17 - Appeals

Right of appeal against PLDP decision is to First Tier Tribunal (FTT), by way of re-determination in relation to the following:

- Refusal to include
- Impose, maintain or vary conditions
- Removal
- FTT can make any decision NHS England could make
- No costs implications unless on application
 Tribunal satisfied party or representative acted in bringing, defending or conducting proceedings (high threshold)
